
MARKETING ON THE MOV

Practice Group Marketing

Proposals, seminars, direct mail programs, capabilities, newsletters and media/article placements have been a few of the high areas of concentration for the practice areas throughout the first half of this year.

- Jim Dorsey achieved successful results with a tax mailing to 2,800 commercial property owners. He received thirty responses, resulting in his filing petitions for \$56.6 million for sixteen new clients (seven were from firm attorney referrals).
- A new marketing capabilities brochure was developed for the Education Law practice group.

With changes in technology and the wider availability and lower cost of high quality printing we are using more color printing every day. We now periodically use an off-site vendor employing high-end color copying that gives us offset quality printing. We are also working on improving our in-house printing capabilities. Soon we hope to greatly increase our quality and flexibility, while lowering cost and turnaround time.

A new format has been instituted for our practice group UPDATE newsletters, where the print version is designed to be a companion piece, and to compliment, the electronic version. Construction Law and Litigation is the most recent practice group to add an electronic version.
